**AFRICAN AMERICAN HERITAGE COMMISSION** - The Commission shall have the following powers and duties: (a) Develop rules for the conduct of its business, including but not limited to meeting schedules, election of officers, voting, subcommittees, et al.; (2) Develop a plan to identify, create, encourage, promote and implement projects that will recognize, increase and expand the awareness of the contributions of African-Americans throughout the City-County area; and (3) Create plans to identify and recognize sites in the community that are significant to African-American history; encourage and promote economic activity related to the African American community; and propose other projects that are consistent with the goals of the Commission.

**BOARD OF ELECTRICAL EXAMINERS** – The members of the Board examine applicants for licenses for the transaction of other related business.

**CIVIC CENTER COMMISSION** – Some duties of the Commission include (1) reviewing and making recommendations on programming goals and objectives for each venue in the Civic Center; (2) establishing a method for handling of customer service complaints; (3) developing and making recommendations regarding long range plans for the Civic Center; (4) reviewing and making recommendations on proposals for changes in the fees and charges for use of Civic Center facilities; (5) encouraging promotion of sports, recreation, entertainment and cultural events and activities, and to facilitate the use of the services and facilities of the Civic Center; and (6) performing other such tasks and functions as the City Council may direct.

DOWNTOWN COMMISSION – <u>Desirable characteristics include someone with an arts</u> <u>connection; a downtown property owner and/or a downtown business owner with</u> <u>vested interest in the downtown</u>. The Commission was established for the sustainability and continued development of downtown, a vital urban center of western North Carolina's economic, cultural and visitor activity. The Commission's purposes include: (1) recommend to City Council an overall policy for the continued development and sustainability of downtown; (2) provide recommendations for effective management of the public resources for downtown and actively pursue and assist private sector investment in the downtown area for the welfare of the citizens of Asheville; (3) carry out the powers and duties assigned to the Commission regarding downtown design review; and (4) cooperate with and evaluate and represent the recommendations of other organizations.

**HISTORIC RESOURCES COMMISSION** - Some duties of the Commission include (1) recommend to City Council and County Commissioners "historic districts" and "landmarks"; (2) restoring, preserving and operating historic properties; (3) recommend to City Council and County Commissioners that designation of historic districts to be revoked or removed for cause; and (4) review and act upon proposals for alterations, demolitions, or new construction within historic districts, or for alteration or demolition of designated landmarks. Members shall have a demonstrated special interest, experience or education in history, architecture or related fields.

**HOUSING AUTHORITY -** The Commissioners are the policy-makers and governing body of the Housing Authority. They review and approve all budgets for the Department of Housing and Urban Development, approve plans and specifications, award contracts and appoint the Executive Director.

MULTIMODAL TRANSPORTATION COMMISSION - <u>Seats open are for representatives</u> <u>from the Transit Commission, the Greenway Commission, the Bike & Pedestrian Task</u> <u>Force, and the Neighborhood Advisory Committee</u>. Members shall represent various modes of transportation to include, but not be limited to: transit, greenways, automobiles, bikes, pedestrians, etc. Members shall possess expertise and interest in the sustainability and development of multimodal transportation and demonstrate willingness to participate actively. This Commission The Commission will (1) recommend policies for the development/ integration of multimodal transportation planning and education to the City; (2) assist with the development of a multimodal transportation system; (3) assist the City with the implementation of best management practices for educating the public on the benefits of multimodal transportation plan; and (5) assist in the prioritization of the Capital Improvement Plan as it relates to multimodal transportation projects.

**NEIGHBORHOOD ADVISORY COMMITTEE**— The Committee was established to advise the City Council on neighborhoods within the City of Asheville's zoning and planning jurisdiction. The Commission shall have the following powers and duties: (1) Develop rules and by-laws for the conduct of its business, including but not limited to meeting schedules, officers, voting, sub-committees; (2) Develop a plan to strengthen neighborhood identity and resilience, and to facilitate communication and cooperation between Asheville's neighborhoods and City offices; (3) Develop benchmarks and standards by which progress towards implementing the plan can be measured; and (4) Work on special projects that are consistent with the goals of the committee, as assigned or directed by Council.

**NOISE ORDINANCE APPEALS BOARD** – This Board will advise the City on matters related to noise and noise control, and will hear and decide appeals and complaints from citizens.

**PUBLIC ART & CULTURAL COMMISSION** – The Commission is responsible for promoting and maintaining art displays in public buildings and public spaces in the City of Asheville. In addition the Board (1) facilitates public art in public buildings and public spaces; (2) informs the residents of and visitors to Asheville about public art; (3) advances the City of Asheville

**BOARD OF ADJUSTMENT** - The Board (1) hears and decides applications for approval of variances from the terms of the Unified Development Ordinance (UDO), except where the UDO places responsibility for hearing or considering such a variance with another body; (2) hears and decides appeals from any order, requirement, permit, decision, or determination issued or made by an administrative officer of the City in enforcing any provisions of the UDO; (3) services as the City's Housing Code Appeals Board; and (4) performs such additional powers and duties as may be set forth elsewhere in the UDO and in other laws and regulations.

Members shall have a demonstrated special interest, experience or education in history, archeology, architecture or related fields.

**METROPOLITAN SEWERAGE DISTRICT BOARD** – The members oversee the operation of the Metropolitan Sewerage District, as well as holding hearings on issues at hand.

**RIVERFRONT AREA REDEVELOPMENT COMMISSION** – <u>APPLICANTS MUST SPECIFY ON</u> <u>THEIR APPLICATION IF THEY ARE A PROPERTY OR BUSINESS OWNER IN THE RIVERFRONT</u> <u>DISTRICT AND IF SO, PROVIDE BUSINESS NAME AND ADDRESS.</u> **TWO VACANCIES ARE FOR A PROPERTY OR BUSINESS OWNER IN THE RIVERFRONT; AND ONE IS FOR AN AT-LARGE SEAT.** The Commission shall (1) recommend to the City and County an overall policy for the continued development and sustainability of the regional riverfront; (2) provide recommendations to the City and County for effective management of the public resources for the districts; (3) actively pursue and assist private sector investment in the districts; and (4) cooperate with, evaluate and represent the recommendations of other organizations, including, but not limited to, property owners,

merchants, residents, businesses, tenants, non-profits, institutions and other members of the riverfront and regional riverfront district communities.

**SOIL EROSION/STORMWATER REVIEW COMMITTEE -** The Committee hears appeals from the Stormwater Administrator.

**SUSTAINABILITY ADVISORY COMMITTEE ON ENERGY AND THE ENVIRONMENT**– This Committee will undertake initiatives, at a City level and participate in the larger community and regional discussions, to improve the environment, encourage green development, and support the development of a healthy community.

**TREE COMMISSION** - The purpose of the Tree Commission is to foster the preservation, planting, replacement and removal of trees without denying the reasonable use and enjoyment of real property. The Commission's responsibilities include: facilitate the planting, growth and protection of trees within the City; foster the communication and coordination among the citizens of the City that would provide the needed support for protection of trees within the City; conduct continuing research, planning and feasibility assessments required to support the purposes of the Commission; and work with City staff to promote and enforce Chapter 20 of the Code of Ordinances of the City of Asheville regarding the regulation of planting, protection, preservation and removal of trees.
