At the City Council meeting held on June 28, 2016, you were appointed as the representative of the Asheville Short-Term Rental Advocates on the Accessory Dwelling Unit (ADU) Task Force.

As I'm sure you know, the City of Asheville recruited a community Task Force to help shape decisions about ADU homestay rentals. The City of Asheville currently does not allow full-home short-term rentals in residential neighborhoods but does permit homestays provided certain conditions can be satisfied. A homestay is a legal form of short-term renting where the owner or resident manager resides on the property full-time. Under Asheville's current homestay rules, an ADU may not be used as part of a homestay operation; although, ADUs (such as garage apartments and cottages) can be legally used for long-term rentals in residentially zoned areas, with "long-term" defined as anything rented for one month or longer.

You will be expected to attend approximately six meetings between July and September 2016 to research, discuss and recommend programmatic and land use regulations related to the potential use of ADUs as part of a homestay operation. You will will not be responsible for researching, discussing or recommending changes to either general standards regulating homestays, nor to the position to continue to prohibit whole-house rentals, as City Council recently approved an ordinance (on November 17, 2015) that addresses these issues.

Council feels that you will work respectfully together with the rest of the Task Force to create well-informed recommendations for programmatic and land-use regulations in the Fall of 2016.

Regular attendance for the task force is crucial for this effort. The first meeting is anticipated in July 2016.

 - Increases in property taxes which force existing residents to find ways to pay for higher cost of staying in their homes;
 - Increasing cost pressures on property owners from increases in: stormwater, maintenance, taxes, water.
 - Lack of incentives for property owners to make rental prices affordable.
 - Incentives move costs to the public which then pay for them through increased taxes.
 - Then there is the "decision" as to who should be afforded the right to live in a city where the cost of living is higher than they can afford. Who or what authority plays God in granting that privilege?
- 2. What would you envision as the preferred outcome of this task force?
 - To make proposals to city council that balance the interests of all parties impacted by decisions that relate to Accessory Dwelling Unites (ADU's).

Under Asheville's current homestay rules, an ADU may not be used as part of a homestay operation; although, ADUs (such as garage apartments and cottages) can be legally used for long-term rentals in residentially zoned areas, with "long-term" defined as anything rented for one month or longer.

Task Force members will be expected to attend approximately six meetings between July and September 2016 to research, discuss and recommend programmatic and land use regulations related to the potential use of ADUs as part of a homestay operation. The Task Force will not be responsible for researching, discussing or recommending changes to either general standards regulating homestays, nor to the position to continue to prohibit whole-house rentals, as City Council recently approved an ordinance (on November 17, 2015) that addresses these issues.

The City seeks a range of collaborative, solution-oriented participants to serve on the Task Force of up to 12 people. The City Council will appoint a group that will work respectfully together to create wellinformed recommendations for programmatic and land-use regulations in the Fall of 2016. The City recommends stakeholder groups nominate individuals to apply to represent their collective interests. Applicants should understand both sides of the debate, the vacation home rental industry, the land use process and/or have other pertinent experience.

There will be approximately eight at-large Task Force seats to be filled by members of the community via an application process. The City intends to distribute those seats evenly among:

- Concerned neighbors who are impacted by the ADU short-term rentals
- Members of the community who own, manage or benefit from such rentals
- Renters
- Neutral but interested individuals

There will be four other seats filled by representatives from the following stakeholder groups:

- Asheville Short-Term Rental Advocates
- Asheville Neighborhood Advisory Committee
- Asheville Board of Realtors
- Asheville Affordable Housing Advisory Committee

The above groups will nominate three individuals each from their respective organizations. In June 2016, the city's Governance Committee will select one representative from each of the four groups to serve on the ADU Task Force.

Regular attendance for the task force is crucial for this effort. The first meeting is anticipated in July 2016.

1. What do you see as the major challenges faced in Asheville's current housing situation?

Asheville has a substantial share of old and deteriorated housing stock. The current surge of popularity in shortterm rentals has had some great benefits in stimulating much-needed upgrades to meet the demand for attractive lodgings.

On the other hand, that surge is putting price pressure on units available for long-term rentals in those same neighborhoods.

At the same time, visitors and full-time residents alike must cope with the fact that streets in the older neighborhoods were not designed to handle so much car traffic and on-street parking.

I see as a major challenge the need to reconcile the Asheville city codes with the realities of short-term whole house or ADU rentals that should be legal in a market economy.

2. What would you envision as the preferred outcome of this task force?

I oppose any solution that involves creating a black market: grandfathering in existing ADU units and excluding future units. I oppose the city's getting involved in licensing individual properties: trying to micro-manage part of the market economy.

I hope for some outcomes that would address issues that visitors and permanent residents share: off-street and on-street parking needs, traffic safety, noise, density.

As I'm sure you know, the City of Asheville will be undertaking a community visioning process for city-owned properties at 68-76 Haywood Street and 33-37 Page Avenue in downtown Asheville. The city has retained the Asheville Design Center (ADC) for this effort, who will work with city staff to facilitate the community visioning process. The outcomes will be designed to inform future actions on the subject sites and surrounding rights-of-way (the "Study Area"), which may include a future design competition and/or a Request for Qualifications/Proposals. The project's scope will include strategic planning and coordination with an Advisory Team, key stakeholders, as well as the broadest community interests who express a desire to participate in an open, democratic "town hall" process of consensus building. Engagement with local stakeholders and property owners will inform a long-term vision for the properties, while also serving to identify opportunities for temporary installations to enliven the space now and suggest appropriate permanent uses on the site over time.

COMPREHENSIVE PLAN ADVISORY COMMITTEE - The City of Asheville will be undertaking a 15 to 17 month process to update its Comprehensive Plan. The plan will establish a vision for Asheville and include policy guidance, reflecting the community's vision for the location and form of future development, while ensuring sufficient infrastructure, parks and other community services. The planning process will include extensive public engagement that is designed to inform a new vision for Asheville. The city has retained the services of Skidmore Owings and Merrill (SOM) to lead this effort. SOM will work with city staff to facilitate the planning process. The purpose of the Comprehensive Plan is to set forth goals and policies for sustainable growth and development over the next 10-20 years and beyond. The plan will include strategies related to land use, multimodal transportation, economic development, social equity, infrastructure, housing, livability, placemaking, open space, climate change adaptation, and sustainability.

I would point out that the cost of maintaining a few stretches of pervious pavement needs to be compared to the cost of repairing slides and collapses due to stormwater runoff from an inappropriately sited impervious pavement. Also, this is an evolving technology and there are numerous kinds of pervious pavement nowadays, surely with varying maintenance requirements.

This is a larger city problem, and it would be prudent to use this opportunity to explore these options. Our entire region is very vulnerable to erosion in these days of climate change and its fierce downpours -- yet we are continuing to increase the problem by

approving acres of new asphalt roads and parking lots that require elaborate runoff catchment and filtering (when we even require that). We are prevented by current state politics from reducing our erosion risk by expanding our steep-slope ordinance, and if the legislature has its way with a bill it's currently considering, we won't even be able to keep the wimpy stream buffers that Council barely managed to pass a few years ago over stiff opposition from "property-rights" lobbyists.

We shouldn't decide whether customized pervious pavement is viable based on what we've heard or what one single landscaping designer says -- certainly not on what Parks & Rec considers too much extra work, considering how much time I see them keeping city-maintained lawns mowed to a nub when it's a far better stormwater practice to mow less often and let them grow to about 4" long.

We have a Stormwater department, and we have a nationally respected hub of stormwater research and expertise practically next door at NC State. Why not commission our stormwater staff to collaborate with NC State researchers (they'll work with us for free) in exploring and testing various pervious options? At the very least, publicizing such an effort would help draw attention to this problem and help generate public, developer, and landscaper support for better regulations and practices.

I have no intention of posting anything public on any of those threads about the APD mess but I work with the USDOL and NCDOL for a living and wanted to mention a couple of things I haven't seen addressed.

First of all, when someone files a complaint, the DOL (either one) sends a letter to the address and contact info provided by the person making the complaint. They then send a letter explaining the complaint to that address and give the employer 30 or so days to respond. The letter is pretty innocuous, contains a bunch of cheap looking xeroxed pages of the statute, and is easy to overlook if no one reads it. If the employer does not respond, it is an uncontested complaint and they issue a decision taking the initial complaint as true.

That is the whole 'investigation'. If it were up to me, I would confirm with the DOL that such a letter was sent, find out when and where it was sent, and track it from there.

It is likely that it was sent and then intentionally or unintentionally misdirected, thence the decision with no investigation.

If it was an intentional misdirection, you have some serious malfeasance.

It would also be interesting to see how the complainant had it addressed. Sounds like a 'gotcha' process to me.

However, I have had plenty of clients put a DOL complaint in a 'get to it later' pile because at first glance it doesn't appear like an important communication.

On the other hand, the APD should have people or access to people who are better able to handle these issues, as the USERRA issue (can't make a person on military leave get their own replacement) is pretty elementary and following up on a DOL complaint also should be pretty elementary.
