WHEREAS, Resolution No. 91-67, adopted on April 23, 1991, established the Citizens/Police Advisory Committee, designated the membership of the Committee and established the duties of the Committee; and

1. Section 2 of Resolution No. 91-67 be and is hereby repealed in its entirety and the following new Section 2 is hereby adopted in lieu thereof:

"Section 2. The Committee shall include the following membership:

- a. Five (5) area representatives from the north, east, south, west and central areas of the City of Asheville. Said representatives shall be appointed by the City Council and serve terms of two (2) years or until their successors are duly appointed.
- b. One (1) Council member.
- c. A youth representative (President of student body of Asheville High School, Roberson High School, and A.C. Reynolds High School; each to serve for a one (1) year term on a rotating basis in the order set forth hereinbefore, retroactive to April 23, 1991).
- d. The Chairman of the Asheville-Buncombe Community Relations Council.
- e. A police officer Asheville Police Department Sergeant in Community Relations Office or his designee.
- f. Chairman of the Housing Authority or their designee (Designee must be a member of the Authority).
- g. Chief of Police to be a non-voting member.
- h. Two Ad Hoc seats, to be temporarily filled and appointed by committee members for a specific problem, incident, or event."
- 2. Except as herein amended, Resolution No. 91-67 shall remain in full force and effect.

3. The following persons are hereby appointed as the five (5) area representatives to serve until the 1st day of May, 1996, or until their successors are appointed:

North: Henry Southworth, 63 Pinecroft Road, Asheville, N.C., 28804-1821

East: Lonnie Blair, 25 Wake Robin Way, Asheville, N.C., 28805

South: Janice Van Dine, 8 Oakwilde Drive, Asheville, N.C., 28803

WHEREAS, the two ad hoc members of CPAC are currently appointed by the CPAC without terms; and

WHEREAS, Council believes it is in the City's best interest that two ad hoc seats of CPAC be at-large seats appointed by City Council with three-year terms;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ASHEVILLE THAT:

The composition of the CPAC be amended to (1) have the ABCRC seat converted to one dedicated to a resident of property owned by the Asheville Housing Authority; and (2) the two current ad hoc members become at-large seats appointed by City Council with three-year terms.
