We are trying to get some guidance on plan revisions to increase the size of the parking lot at Hunt Hill/Memorial Park. Ted already commented on the plans (permit #17-00852).

This is part of the Parks Maintenance Relocation, and is a temporary move (about 2-yrs, maybe 3-max). Couple more items:

There are a lot issues going on at the entrance if we need to provide a 24' opening and/or a 10' paved entrance. It is very atypical due to the access easement. The

existing fence opening is about 22', so it is shy of the 24'. If there needs to be 10' of pavement at the entrance then that puts us into having to pave/patch. There's a water structure visible on google earth (valve or something). There's a sign and the gate post that could have to be moved. A result is that the gates would not meet anymore in the middle.

Beyond this, the additional work and planting may push us over an acre. My suggestion if that is the case is to replace the filter strip with a rain garden. I think the cost would be comparable and the footprint could be reduced. I've got details, etc. from the greenway projects that I can use so in terms of my time it is not that bad of a modification.

I've got a question in to Nancy asking about whether the planting needs to be included in the LOD.

I'm going to hold tight a bit and wait for feedback on these various things, but I will switch right back over to getting this completed when I hear back.

2. Please add a COA construction Entrance to the details, just in case they need it.

Note: The later is a request, as this ESC, is one of the projects that would not be regulated. As it is a local government project ESC regulation would fall to the state. Since it's under an acre, the state threshold for requiring a permit is not met. In these cases we typically issue a cursory grading permit, so our inspector in the area is aware of the project, specifically if there are issues or complaints.

Yes, a face to face update would be good to go over the plans for the Parks & Rec relocation. The neighbors of Hunt Hill were under the impression that we would have some answers to the questions we sent in early November. Is there any way you can make sure that answers to the following questions are provided at that meeting (or before)? Some of these were addressed and others were not.

- How many people will be working there everyday?
- How many cars will be parked during the day & where will they park?
- When and how many trucks will be going in and out everyday?
- Where will the "71 pieces of equipment" go?
- What types of improvements will happen to the property (trees, landscaping, exterior work on the building, fencing, etc)?
- How will P&R help to integrate into our neighborhood and be good neighbors?

The gates to Mountainside Park are actually NOT being locked and residents of the Retreat are still using the park to park their vehicles during the day and overnight. We had heard that there were no firm plans to do that until Parks & Rec moved in. Is that true? We had expected that the gates would be locked within 2 weeks of the meeting we had at the end of Oct.

In that same meeting, Chip Kassinger agreed to install pavement ribbons in the pavement near the new stop sign at the exit of the complex. To my knowledge, those have not been installed and many residents from the apartments continue to not observe the stop sign. As far as his agreement to install a separate dog park for the residents, I do not know if that has been done. Can you find out for me? Chip had also said he would notify the residents to not park in Mountainside Park.

We did form a sub-committee with Hunt Hill residents to focus on the issues at hand and for all future plans for the park and city building properties. I would like to take you up on a meeting in early January to talk about the details of the relocation of P&R AND to begin the conversation for any future plans of the area. I realize you and everyone at the city is super busy, so I am committed to stay on top of the conversation and will be checking in often.
