# <u>CERTIFICATE OF SUFFICIENCY</u> <u>PETITION FOR SATELLITE ANNEXATION</u> 5 HILLTOP DRIVE (7641-68-1650)

To the Board of Commissioners of the Town of Sylva, North Carolina:

I, Amanda W. Murajda, Town Clerk, do hereby certify that I have investigated the attached petition and hereby make the following findings:

I further find that the area meets the standards for a noncontiguous area as specified in G.S. 160A-58.1(b), in that:

- 1. The petition includes a metes and bounds description of the area proposed for annexation and has attached a map showing the proposed satellite area in relation to the primary corporate limits.
- 2. The petition includes the names and addresses of all owners of real property lying in the area described therein.
- 3. The petition includes the signatures of all owners of real property lying in the area described therein, except those not required to sign by G.S. 160A-58.1(a).
- 4. The nearest point on the proposed satellite corporate limits is no more than three (3) miles from the primary corporate limits of the Town;
- 5. No point on the proposed satellite corporate limits is closer to the primary corporate limits of any municipality other that the Town.
- 6. The satellite area is so situated that the Town will be able to provide the same services as are provided with its primary corporate limits.
- 7. To the extent that the proposed satellite area contains any portion of a subdivision, the entire subdivision is included;
- 8. The area within the proposed satellite corporate limits, when added to the area within all other satellite corporate limits of the town of Sylva, does not exceed ten percent (10%) of the area within the primary corporate limits of the Town.

# RESOLUTION FIXING DATE OF PUBLIC HEARING ON QUESTION OF ANNEXATION PURSUANT TO G.S. 160A-58.2

WHEREAS, a petition requesting annexation of the non-contiguous area described herein has been received; and

**WHEREAS**, the Town of Sylva has by resolution directed the Town Clerk to investigate the sufficiency of the petition; and

WHEREAS, certification by the Town Clerk as to the sufficiency of the petition has been made;

**NOW THEREFORE, BE IT RESOLVED**, by the Board of Commissioner of the Town of Sylva, North Carolina that:

Section 1. A public hearing on the question of annexation of the non-contiguous area described herein will be held at the Town of Sylva Municipal Hall at 5:30 p.m. on September 12, 2019.

Section 2. The area proposed for Annexation is as follows:
