

# **Enka FFA Barn Project**

Our program pride's itself in providing students with hands-on and real-world experiences. Our model for education has three parts: Classroom/Laboratory, SAE and FFA. All three of these parts will be enhanced by this barn project. Through having this barn we can help students apply classroom concepts in a real world setting. Through this barn we can help students prepare for various FFA contests through having our own animals here at the school. We can also provide students with opportunities to gain hours for their Supervised Agriculture Experience project. We feel that the students in the Enka/Candler community deserve the opportunity to gain valuable skills in animal science that will help them in their future career endeavors. Our current animal housing facility was created by converting half of our tractor shed into a makeshift barn for our 3 dairy steers that we raised this year. Our Animal Science classes cover species including poultry, cattle, swine, sheep, goats, horses and small animals preparing students for a plethora of careers in Animal Science. Right here in Buncombe county there are 613 animal farms and animal agriculture is valued at \$15,155,000 in the county. When asked, students responded that working with the animals hands-on helped reinforce class concepts and made them excited about coming to school so that they could work with the animals. For many students, working with the animals was therapy after a stressful day all while still teaching them valuable lessons in animal agriculture. This project has united faculty, parents, students and community members and created excitement for these stakeholders during the COVID-19 pandemic. This Barn Facility will hold a lasting impact and be a source of pride for not only the Enka/Candler community, but for the entire county. Below is a picture of our current facilities.






