Gentlemen,

I believe at this point that I have had the opportunity to speak with all of you except Mr. Travis about the goal of adding "Passport Agency Services" to the Registers of Deeds Office. Adding this service to the office is one of our initiatives here at the Register's Office to help with the county's budget, while also adding what I believe to be a much needed service here in Rockingham County.

I have always maintained that all elected officials should work together and share the responsibilities to better the county. It's my goal to help the elected commissioners and county manager solve the difficulties our county currently faces when ever opportunity allows. The first step in this would be to better the relationship between the Register of Deeds Office and the board of commissioners. I would like to take this opportunity to invite each of you to the office when ever you are in area. The Registers of Deeds team and I would like to establish a better relationship than has been fostered in the past.

I am sending this email to make sure everyone is on the same page as to where we are in the process, and what realistic expectations can be anticipated with the addition of the "Passport Agency Service".

This week we made application to the United States State Department in Washington D. C. requesting that they review our office for approval. I was advised that this process can take two weeks to two months before we will have an answer. If approved, and I believe we will be, we can be up and running by late May or early June of this year. I have spoken with Mr. Metzler and advised him the start up cost of adding this service will be minimal, and that any necessary funds needed will be pulled from our shared savings. By using our shared savings fund we will be able to add this valuable service to our office at no additional cost to the tax paying citizens of this county. We will be utilizing funds our office already has in place and set aside for what I believe to be improvements like this to be made.

The currently unused portion of our office will become the "Passport & Veteran" services area of our office. At this time we plan to have two full time work stations devoted to citizens seeking these services. I have been in contact with Jeff Thigpen, Guilford County Register of Deeds. His office added the Passport Services in November of 2016 and he was the second Register in the state to offer this service.

Here are the numbers Mr. Thigpen has from just two months of operation.

Nov. 2016 \$2,155

Dec. 2016 \$3,705

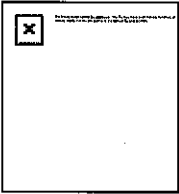
Total: \$7,325

The Guilford office has issued 237 passports in just two months with limited advertisement, and on an appointment only basis. That is an additional \$7,325 revenue going in the Guilford County general fund. Mr. Thigpen began advertising this service with the local media on December 28, 2016, and I will stay up to date on the progress his office makes with this program. Based on Mr. Thigpen's early numbers I believe our office will be able to generate an additional \$30,000 to \$40,000 annually with the addition of this service.

We realize that \$30,000 of additional revenue pales in comparison with the current deficit the county is facing, but we are committed to doing our part to help. And if we can add a service that covers one of our salaries that is something we will be glad to do. We just need some time to get this service up and going.

I was able to talk to Jason Julian today. He wanted me to be specific so he could scout the spots and then meet with maintenance before they put them up. E. Recertification

In the event a person fails to meet the continuing education requirements in any year, his or her certification shall be withdrawn. The board may recertify a previously certified register of deeds, or assistant or deputy, when the applicant for recertification presents to the board evidence of satisfactory completion of a total number of continuing education hours in the year in which the recertification is sought that equals ten times the number of years in the case of a register of deeds and five times the number of years in the case of an

assistant or deputy that have elapsed since the certification was withdrawn. If a register, an assistant or deputy leaves the office after being certified, and then returns to the office and (1) attends the School for Register of Deeds offered through the School of Government, (2) passes the exam and (3) applies for recertification, they will be recertified without having to make up the hours of continuing education credits. The Certification Board has the discretion to consider extenuating circumstances, and, upon a certification holder's request, must rule on whether a failure to comply with continuing education requirements is attributable to extended illness or an emergency situation.
