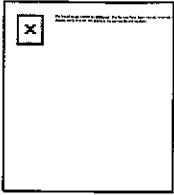

The county updated the web site this past week and it they are still working out the kinks. Thanks for letting me know about our web site issues. Parts of the web site are not mobile device friendly.

As for the District Attorney and a Temporary Restraining Order, I am not a lawyer. But having said that my thoughts are that District Attorney's only deal with things that are currently under criminal investigation. The situation you find yourself in is a Civil Matter at this point. An accusation of fraud is merely an accusation until evidence is obtained, Probable Cause, that a crime actually took place. What your wanting to happen is for someone to investigate your claim to see if Probable Cause exists then making it a criminal case and putting it in the jurisdiction of the District Attorney.

Law enforcement will not touch this as it is a Civil Matter at this point and Detectives / Officers are not familiar enough with Real Estate laws. A Real Estate Lawyer will be able to review your files and determine if you have been treated fairly or not. If that attorney determines that something illegal has taken place they can file an injunction with the Clerk of Court's Office.

Again, a Real Estate Attorney is your best / only option in my best judgement. But I am not a lawyer...

I honestly have multiple goals for this. I promise you there is a method to my madness. A lot of officers are former military and they have no idea about our Veterans ID card program, and our Fraud program is one of our "Department Objectives" as well. They also have no idea we offer that service. Being a former Detective I had never heard of the Register of Deeds Fraud program. So I plan to have handouts for each Chief for the Veterans & Fraud program asking them to help spread the word on both programs. This should help boost both numbers for us with those two projects.

Also, on May 15th we will have our Passport program up and running. We are planning for 225 officers to pass through on May 15th. That is 225 "word of mouth" people that when asked about Passports we will tell people to come to us and not the post office. The First Responder's Day at \$9.00 a person, and 225 people is \$2,025. When we do this again in November for the Veterans we will only plan for about 50 people at a cost of about \$450.00. I plan to hit up the County Commissioners for \$100 each to pay for that one...

I want these two events to become annual events and I know shared savings doesn't bring in enough to sustain both year in and year out. I hope to work on Sponsors for the First Responder event for 2018 and the Commissioners for the Veterans ones. Starting in 2018 I plan for the Responder's Day to be "Sponsored by" & "Hosted by the Register of Deeds" and the Veterans to be "Sponsored by the Rockingham County Commissioners" and "Hosted by the Register of Deeds".

Mrs. Harnage,

In the state of North Carolina we fall under the direction of the U. S. Passport office in Charleston, S.C. I will list the contact person below (**Marcy**). I have also attached the Designation Form that has to be filled out and sent back to Marcy.

Right now we will be the fourth Register to offer this service, hoping to start May 1st. The first was Brunswick County in 2003, Johnson County in 2015, and Guilford County in 2016. Guilford just started in November 2016 and their numbers are continuing to increase each month. They expect to hit about 400 a month now that they are advertising the program. All three of those counties are larger than mine and have larger staffs. But our two counties are about the same size, I think you have about 5,000 more people. I have a staff of 6 and me for 7 total people in the office. It's a simple process but will require some restructuring of your office both with personal and space.

1. A passport agent can not have access to the state (Green) certified paper
2. A passport agent can not have any access to Vital records
3. They want the passport agent in a separate work area if possible (wall dividing or office)

So it's like loosing an employee, and they want your office to have at least TWO agents. The other three counties are offering passports by appointment only. We will be the first walk-in register's office in the state. By offering the walk-in it helped us get through the approval process. When you call Marcy and tell her you're interested in applying she will ask if your looking to become a "walk-in" or appointment facility. I was advised to say "walk-in" because that would help us get approved. So that is what I said, and what we are going to attempt. Starting May 1st anyone at any time can come to our office 9:00 AM to 1:00 PM and 3:00 PM to 4:00 PM and apply for a passport. I put a two hour break in the schedule for lunches and so the paperwork for the first four hours can be completed. Everything that comes in that day **MUST** be mailed that day. So your postage budget will go up about \$3,000 but I have done a lot of math and we expect to bring in over \$27,000 in extra revenue (**see my math below based off of the three counties already doing this**).

Each passport completed the county gets a \$25.00 fee. And if a photo is taken that is another \$10.00 fee. From what I have gathered about 66% of the passport applications also have the \$10.00 fee for the photo.

As you can see Guilford has averaged 11 per day in January and 20 per day in February. Their two month average is 270 and that would mean 3,240 per year. I spoke with Cindy (Guilford Assistant Register of Deeds and Head of Passport Program) and she said they are "rolling". They have just started pushing the program and 400 is their goal in March. The Guilford County Register of Deeds has two full time employees doing nothing but passports. And Guilford County has a total of six locations to obtain passports they are competing with. We will be competing with only one location here in Rockingham County (Reidsville Post Office, which is appointment only).

Rockingham County Population: 91,878 or 75% of Brunswick County, 52% of Johnson County, and 18% of Guilford County.

$$1,300 \times 75\% = 975$$

$$1,858 \times 52\% = 966$$

$$3,240 \times 18\% = 583$$

I truly believe we will be more in line with the Brunswick & Johnson County numbers, and that the Guilford County number will be much higher. But the average of those three numbers is 841, so I will use that number.  $841 \times \$25.00 = \$21,025$

$$\text{Photos: } 841 \times 66\% = 546$$

$$546 \times \$10.00 \text{ fee} = \$5,466.00$$

So 841 passports should generate about \$26,491.50 for the county, and it's reasonable to expect an additional \$27,000 in revenue from this project.

As we have more and more departments purchasing from Amazon, we are going to open up an Amazon Business Account for the County Government and then create separate user accounts under this master account for those in your department that you want to authorize for Amazon purchases in your department.

The Business Account provides costs savings on purchases and free two-day shipping on orders of \$49 or more. We believe that the County will be able to achieve cost savings by opening the business account and



then asking authorized purchasers to discontinue the use of any existing accounts that they are using and move to the new account that will be assigned and linked to the Master Business Account for the County.

All accounts will be set up as invoice only. This will allow you to purchase without having to use your County Purchasing Card, which will help in keeping the PCard balances lower and lessening the need for us to raise those card limits for purchases such as this.

This will be a business account for the County, so only County purchases can be made through this account. No personal purchasing is permitted.

Amanda Crumpler will be the one to set up the user accounts, so **we need for you to designate those persons within your department that will be authorized to purchase from Amazon and send that information to Amanda as soon as possible.** She will work to get the users set up as quickly as possible.

Once everyone has been set up, we will watch to see that all purchasing is going through the Business Account to ensure that all departments are getting the best price for their purchases through Amazon.

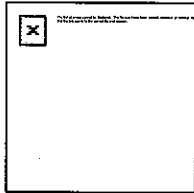

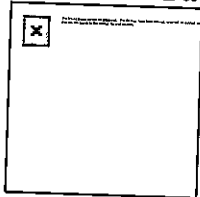

Then we're going to move the existing GIS machine to the back corner.

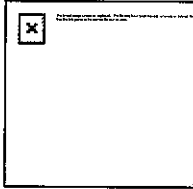

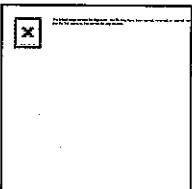

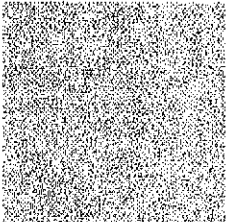

WASHINGTON — Veterans Affairs officials will start issuing new veterans ID cards next month, giving recipients an easy way to provide their military service for business discounts and other promotions.

The move, first reported by Military.com, comes two years after Congress passed legislation for the cards. A VA spokesman said they'll be made available for no cost to any veteran who applies through the department's website.

The new cards won't replace VA medical cards or official defense retiree cards, and will not carry any force of law behind them.

Supporters have called a national veterans ID card a simple way to honor veterans' service and a way to help them prove their service status for non-federal activities. They have also argued that many veterans' practice of carrying around copies of their military discharge paperwork or other personal documents to get corporate discounts leaves them open to fraud and identity theft.
