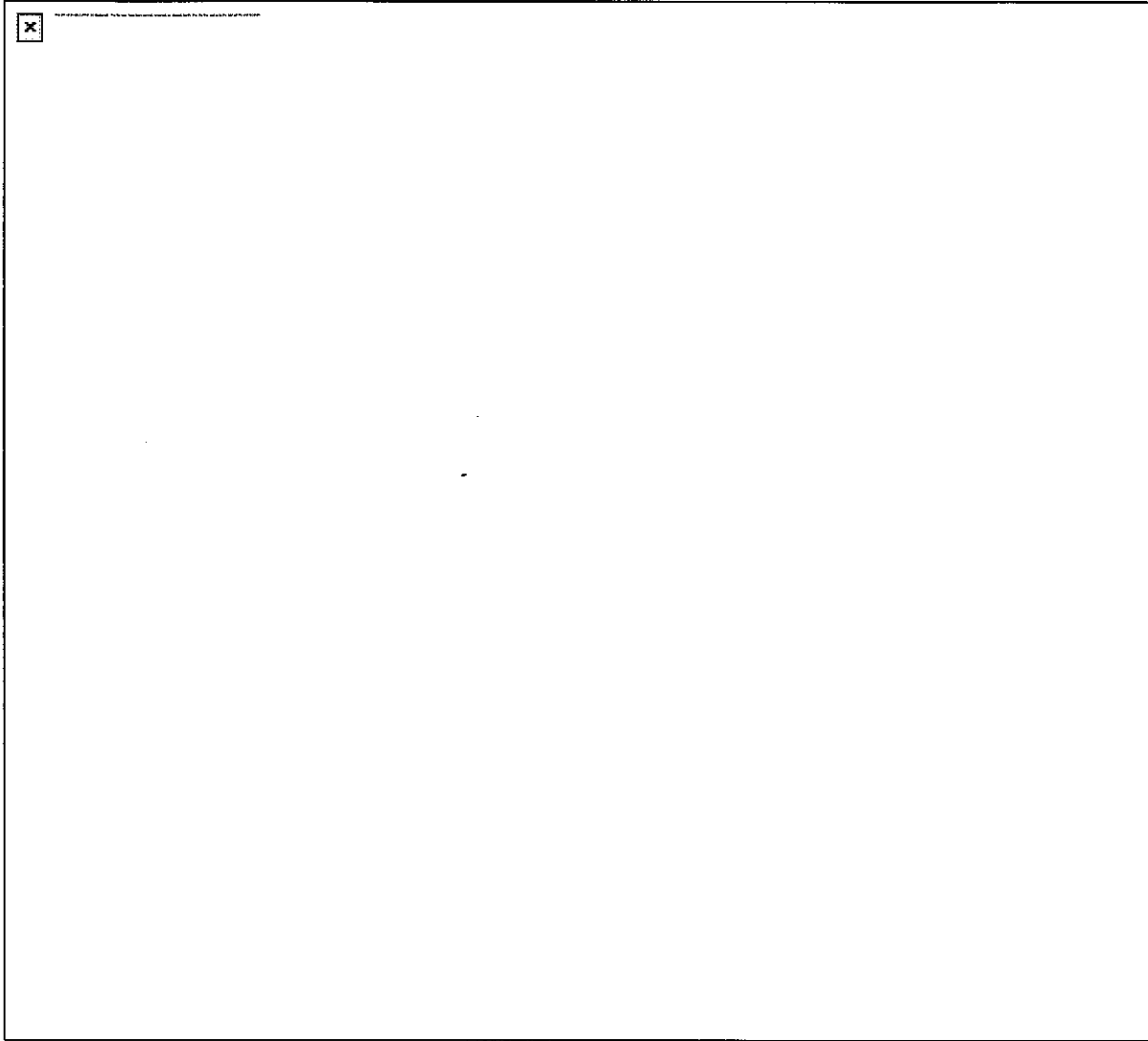

For Nine Straight Years, Six Figures Went Missing from the Wake County Register of Deeds Office

Wake County officials say about \$2.3 million went missing from the **Register of Deeds** office between 2008 and 2017, according to a new insurance claim.

The official amount that's missing—\$2,333,591.30—puts an exclamation point on the ongoing Wake County scandal involving the **apparent embezzlement** of wads of cash, on a near-daily basis, for nearly a decade. In part of the 266-page document dated August 24, director of internal audit John Stephenson lays out the year-by-year trail of missing revenue. An investigation showed amounts in the six figures missing for **nine straight years**—\$124,911.04 in 2008, the earliest year for which records remain, and a peak of \$326,743.31 in 2012.

The "proof of loss" statement signed by county manager **Jim Hartmann** is designed to tell the insurance company "how the loss was caused, when the loss occurred," and other details of the claim. A Wake County investigation and subsequent **State Bureau of Investigation** probe have found that the register's office, under the direction of former register **Laura Riddick**, failed to keep accurate records and handled cash loosely.

Riddick, initially elected in 1996, retired in March, at the same time Hartmann and Wake County District Attorney Lorrin Freeman announced that the SBI would investigate the missing funds. The officials attributed Riddick's departure to **poor health**, not the missing funds. Riddick has not been available for

comment since her retirement. (Hartmann has since announced that he, too, will be leaving his post at the end of October, to move to Florida and be closer to his family.)

Warren sent the proof-of-loss account to a **Travelers Casualty and Surety Co.** office in Charlotte. A two-page narrative says the discovery of the losses began with a move to automate the office's monthly reports. The goal was to track numbers of documents as well as the amount of money received by the office.

But office staff soon noticed **substantial amounts of missing cash** were going undetected. These discoveries started a chain of events that led to internal audits, the announcement of the state investigation, and an employee named **Tray Ellis** confessing to stealing \$50,000.

The county is undergoing an outside audit by the accounting firm **Elliot Davis**, to be submitted to the county on Friday, officials say. Meanwhile, the criminal probe continues.

Since our records only go back to 1913 for births & deaths, and 1867 for marriages we do not have anything for that time frame. The other sources we would recommend and go back that far back are family bibles and records normally kept at home. I have no idea where you could look to find anything dating back to 1825 here in Rockingham County. But Rockingham County was formed out of Guilford County in 1785. I don't know how they handled the transfer of records but it's possible they might have some information that can assist you. And before Guilford County this area was part of Rowan County.

I am trying to find information on my Great, Great Grandfather Richard Henry Wray of Reidsville, NC. I know that he was born October 19, 1825 and died on September 1, 1907. I do not know where he was born or the name of his parents. I do know that he lived in Reidsville, Rockingham County, North Carolina the vast majority of his life according to the various Census Records from 1860 until he died. He was married to Lucy Frances Burton Wray (February 8, 1836 - November 11, 1927). They are buried beside each other in the Greenview Cemetery in Reidsville. I have also heard rumors that he was in the Civil War and would have been around 35 to 39 years old during the War.

I have searched all the genealogical online websites I can find, but keep running into dead ends about who his parents, grandparents, etc. were and seems like the only way I know to find that is through his Birth Certificate in Reidsville if that is where he was born. Not knowing this information has caused our family lots of anguish. If you can find any such records that can help me, I would be extremely grateful.

Questions have been raised about the map review officer requirement as affected by SL 2017-27, in response to the Secretary of State Office's memo of July 26, 2017, describing those changes.

As described on page 3 of the memo, the law has changed slightly regarding the surveyor's obligation to certify the map's purpose, a certificate that affects whether the map must first go the review officer. In some cases, a surveyor's certificate about the map's purpose allows the map to be recorded directly with you. This has been allowed since the review officer process was enacted in 1997. As the Secretary of State Office's memo describes, the law slightly changed some details about the four allowed purposes that already existed (unregulated area, existing parcels, existing buildings or features, or control survey), and added a new purpose that also does not require review officer certification: "That the survey is of a proposed easement for a public utility as defined in G.S. 62-3."

Your process as set forth in the statute remains the same. If the surveyor certifies to one of these (now) five purposes with language that tracks the statutory language in all material respects, the map does not have to go to the review officer. As for what you check, this is what the principal author of the original legislation, Professor Bill Campbell of the Institute of Government, said in his Land Records Bulletin 23: If a surveyor has certified to one of the allowed map purposes that do not require review officer certification, "The only review that the register performs in this situation is to determine that the dimensions of the map are correct and that legible copies can be made from the map."

Unfortunately, I need to make you aware of a problem that we experienced with our payout system for GetCertificateNow.com so that you can decide how best to handle the situation.

It appears as though we double sent some ACH transfers last week. In other words, on particular days you received the same transfer from us twice. The problem occurred because we created a new test server that was a complete replicate of our existing production server. The new test server was created so that we could extensively test an upcoming release for GetCertificateNow.com that includes several new features.

With 2 servers basically being identical, the standard task that runs at 6:00 p.m. every evening to transfer you the money actually ran twice (once on the existing server and again on the replicated test server). The matter was brought to our attention on Friday and the problem was investigated and eventually resolved over the weekend.

In the case of your county, our records show that the following duplicate payments were sent last week.

Rockingham	\$43.00 total across 2 separate payments
tr_1AkK1p2BSBVz4mEzWwRWfPTg	\$11.50
tr_1Ajb4h2BSBVz4mEzLjp1qfBY	\$31.50

Can you check with your finance department and see how they would like to resolve the matter? To ensure that everything reconciles it seems like the best course of action would be for your finance department to cut a refund check. Another option would be for us to try and deduct the cost of the duplicate transfers from future transactions, but this is tricky because it is unlikely that the costs will exactly match because the volume of requests is never the same. The other option would be for you to just keep the extra money, but I wanted you to understand why it was there.
