## Gentlemen,

I have come across a situation and I wanted to gather some thoughts on this. Today I asked what we did with checks that were returned with NSF. This topic came up on the state wide register discussion emails that I receive daily. On the discussion emails some offices advised that they used the District Attorney's worthless check programs, and some advised that the loss was just absorbed into the Register's budget.

When I asked what Rebecca's method in the past for dealing with this situation was I was advised that the office sends letters, and makes phone calls attempting to collect the funds. I was told that this generally works, but nobody could recall what was done when letters and phone calls did not result in payment. I also learned that at this current time we have two checks dating back to April 2016 that we have yet to be able to collect payment on. And I was also advised that this office only has this issue a few times a year.

It being my intent is to use the District Attorney's worthless check program (Ann Bradsher) I asked for the file on both of the checks. After receiving both checks I recognized one of the people involved as being a current inmate in the Rockingham County Jail. I know the family and contacted them about this matter. After I explained the situation they agreed to make payment to cover the check. The family also inquired if we had any additional fees associated with checks returned for NSF. So not knowing the answer to that I contacted Ms. Kelly Burton of the Finance Department. Ms. Burton advised me that the county does not currently collect a NSF fee on returned checks.

#### I explain all of this to get clarification on:

- 1. If we put a sign out at the Registers Office informing the public that checks returned for NSF would have a \$25.00 fee, per the general practice of doing business, would that be:
- A) Legal?
- B) Something the commissioners and county manager would agree with or disagree with?
- C) Would that \$25.00 go to the ROD office since we are doing the collecting or the county?

Same situation for the Assistant Registers please. I am attempting to get a better understanding of our the pay scale works in my office and how it can be adjusted if I wish to do so.



#### Good Afternoon,

The ITS department is preparing to start one of the most needed but more difficult projects we have performed in the last 24 months. This upgrade will affect all users and will require periods of downtime for the file server throughout the process. We will make every attempt to make this upgrade as seamless as possible but I can assure you that many legacy processes will be discovered through the upgrade that will cause items to break. We will work with each area to resolve the issues and get us to a much more stable and supportable environment.

You may ask "Why are we doing this?"

- 1) Currently we have one single point of failure with RCFILE01. We will break the network shares apart into multiple servers to address this.
- 2) In the event the server had to be restored from backup it would take days if not weeks due to the size.
- 3) We need to upgrade the Operating System to a modern Operating System supported by Microsoft.
- 4) Backups for this server often exceed time limits allowed and leave us at risk.
- 5) Why now? A upgrade of this magnitude will never fit into the schedule of everyone. It is more important to reduce the risk of failure than to continue to wait. We also consider it important to resolve this issue prior to migrating to new hardware to reduce overall downtime.
