This letter is to finalize the outcome of the pre-disciplinary conference held with you on Monday, July 25, 2022.

Your statements during the conference were closely reviewed; and the issues as we discussed were further investigated. After careful review and consideration, I must regretfully inform you that your employment with Alexander County will be terminated effective today, Wednesday, July 27, 2022 at 5pm. This termination is based upon Alexander County's Personnel Policy, Article X – Discipline and Dismissal for Just Cause.

According to Munis and effective with submission of the last payroll, your compensatory leave balance is zero hours; and your vacation leave balance is 119.71 hours. The County has agreed to payout the accrued vacation leave. Also, there are five sessions with the Employee Assistance Program available to you at no cost. The County contracts with The Counseling Group out of Hickory, NC for support with this program. You may contact their office at 828-322-8736 and let them know you are calling as part of the Alexander County EAP in order to utilize this service. All hard copy and electronic documents related to work in your caseload must be returned to the Department.

Your employee status grants you the right to file an appeal based upon the procedures set forth in the Alexander County Personnel Policy, Article XI.
