Please provide the names and salaries of ALL current Greenville, NC Police Department employees, as of the present day [on the date the query is performed]. Please include the following:

- 3) Position / title / department
- 4) Salary (including hourly wage, hourly rate, or salary -- whichever payment structure is applicable to the employee)

Ideally, I'd like to receive the responsive records in an Excel or other machine-readable format. If any / all of this info is already publicly available online, please provide a link to where it can be accessed.

Please note that by submitting this request, I'm NOT agreeing to pay any potential fees or associated costs related to my request. If it isn't possible to process the request without incurring fees, then please let me know the itemized potential cost and clear explanations of those charges upfront, and DO NOT proceed until I respond.
