Thanks for spending some of your brain power noodling on this.

First of all none of this is set in stone and I'd love to know what others would like to get out of this opportunity. This draft is largely from my perspective. I'd welcome more input on desired outcomes, and ideas for other federal funding beyond this first NREL with a very tight turnaround window.

1. I don't see specific roles and responsibilities listed in this document. What would be the specific roles and responsibilities of the City and County? What are we committing to?

One thing we hope to get from the meeting next week is at what level the City and County would like to be involved. I could see participating with NREL research and spearheading communication with City and County departments to get the data needed. If one of the outcomes of this grant is specific changes to the Land Use Incentive Grants or Community Benefits agreements, I could see laying the groundwork for policy changes based on those recommendations as a role staff might play. If you could see other uses for this research or something you would like to write into the grant I think that would be something we should explore. If you have any capacity to help with the application on the short time table that would also be welcome!

2. Some of this work has been attempted previously, how are you incorporating that to not get stuck in the same place or move us past previous analysis?

I know Duke and GBA tried to approach high energy users at some point before I was on the council, but don't know the details. I think laying the foundation for those conversations with more detailed modeling on ROI from the research side and relationship development with key "strategic partners" on the community engagement side is the difference. This would give us expanded capacity to do it better. If you have more detail about what data and users were identified and what approached that would be helpful. There may be some additional understanding of this on the BHPCC but it was likely before Jamie or I were involved.

3. What other organizations are submitting letters of support?

We are working on that as we speak. You all are the essential partners so your buy in is sort of first at bat. Ed and Jim have a list and this will be something the community engagement committee takes up. So far, Deerfield and the Rotary Club.

4. My understanding is that Land of Sky will be the lead applicant. If this is the case, will this project serve their region or anywhere else beyond Buncombe County?

Like Sara explained, this would only be for the territory of the BHP - so Buncombe County and helping to meet our community 100% clean energy goal.

5. Will this grant include any facilitation specific to BHPCC?

I am not sure if I was thinking about this in terms of facilitation of the BHPCC, but more in terms of capacity to do outreach, but if the BHPCC is part of community engagement than some facilitation may be part of the scope. This is only a 3 year grant so I would not shift long term facilitation based on this funding, but could see it as an enhancement tool.

Keep them coming! What else should we be bringing into focus?

Thank you for this information. This is the first I am hearing of this effort and there is a lot here to consider. I agree we need to meet and discuss, however, I am at a conference next week and will not be able to meet on May 22. Can we look at the week of May 28th?

I will continue to review the information you provided but at glance I do want to share that I don't think that EECBG is an option. The City and County have already applied for our formula funding. My understanding is that the competitive grant funding was only available to local governments not eligible for formula funding (so would require a lead agency outside BC) and I think they awarded those grants already.

Hello Bridget, Jeremiah, Kiera, and Jackie,
and Commissioner Newman, Commissioner Sloan, and Councilmember Ullman,

There has been a lot of discussion at the BHPCC about the potential grant funds that are available from the federal agencies to support the shared goal of transitioning to clean energy. I am aware that it is really beyond the ability of the council to administer these grants and want to kick off a dialogue with you, our government partners.

I believe that Buncombe County is well positioned to take advantage of the C2C opportunity from NREL, full RFP attached as well as a brief summary of what I see as the potential goals for the grant, within that summary is a link to the start of the grant application. This summary is informed by initial conversations with City/ County staff and Jennifer Bennet from Duke Energy, as well as a longer conversation with Land of Sky staff and Jamie from GBA who are also included on this email. You can provide feedback by commenting directly in this [REDACTED] document, or send feedback to myself and Jamie.

I am sure many of you are aware of the EECBG and Climate Pollution Reduction funds coming to other communities in NC for weatherization and low income solar installations. We could also pursue these funds, as a compliment to the forthcoming

Solar For All program. [Here is the link to the EECBG](#) FAQ; that application is due in October.

Federal grant applications and reporting can be cumbersome, we understand. Land of Sky staff, Sarah and Ian, have experience and are willing to support this work and may even serve as the recipient of the funds. If the City or the County also have additional grant writing capacity, please let us know. The grant writer for Durham County has been essential in securing funds for the [EBERP program](#), and that the Centralina and Central Pines COGs have been successful in getting funds for subsidized solar.

It would be beneficial for us to set up a call to talk about these funding opportunities. We have a standing meeting coming up next week to plan the BHPCC meeting at noon on May 22. We could extend the meeting for this purpose -- though time is essential with the NREL application due on June 15th. At minimum we need a letter of support from the City, County, and Duke.

I look forward to continued conversation and to bringing resources to support our vision for a sustainable and clean energy future in Buncombe County.
